

## PRIVACY POLICY

Welcome to the Alternativa Film Project. We are committed to protecting your privacy. This policy describes our privacy practices, the personal information we collect, how we use and share it, as well as your choices and rights regarding this information.

This Privacy Policy applies to all visitors of our website <https://alternativa.film/> and participants of the Project ("**you**").

We comply with local laws in relation to all practices described in this policy. If there is an inconsistency between this policy and the local law, we will comply with the local law to the extent of the inconsistency.

### WHAT INFORMATION WE COLLECT

To review Program participant applications, we request the following information:

- Full name;
- Participant's contact information: email address, phone number, passport information;
- Participant's place of residence;
- Information about the participant's social networks;
- Motivation letter of the participant;
- Information about previous projects, work experience, achievements, as well as other information specified in the CV;
- Photo/video image;
- Other information about the participant, which the participant will provide additionally.

### HOW WE USE YOUR INFORMATION

We use your information for the following purposes:

- Organization of the Program's activities;
- Reviewing applications;
- Communication with participants;
- KYC check of participants;
- Travel Organizations;
- Ensuring secure and stable operation of the Program sites;
- Promoting the Program.

### HOW WE SHARE YOUR INFORMATION

**With external experts:** We may share your personal information with external jurors and tutors for the purpose of organizing the program.

**With website visitors:** We may share your personal information with other visitors to our website, for the purposes of shortlisting participants and publishing program results.

**With our corporate group:** We may disclose personal information to our corporate subsidiaries or other entities affiliated with inDrive.

**With our providers:** We may partner with third-party providers such as travel agencies to book tickets and hotels.

**For marketing:** We may cooperate with third-party marketing platforms and service providers to assist us and perform certain marketing services for us. We may also disclose personal information to share with the result of Projects on our social media pages.

**For legal reasons:** We may disclose your personal information when it is necessary to comply with legal requirements or to protect the rights.

## **YOUR RIGHTS AND CHOICES**

**Accessing, amending or deleting your data.** You may access, amend or delete your personal information that we hold by contacting us at the email indicated at the end of this policy.

**Managing cookies.** You can delete cookies and modify your cookie settings on your browser. You may need to separately manage cookies for each type of browser or device.

**Unsubscribing from marketing emails.** You can opt out of marketing emails messages by using the “unsubscribe” link or mechanism noted in such emails.

**Asking us questions or raising a complaint.** We will be happy to answer any questions you may have about this policy or about how we treat your information. We will respond to your request consistent with applicable law and subject to proper verification of your account and identity. If you wish to raise a concern about our use of your information, you have the right to complain to your local supervisory authority.

## **HOW WE STORE YOUR INFORMATION**

We retain your information for as long as necessary to achieve the purposes set out in this policy. We may also need to retain some of your information for a longer period to comply with our legal and regulatory obligations.

## **HOW WE PROTECT YOUR INFORMATION**

We take reasonable and appropriate technical, administrative, and physical security measures, appropriate to the nature of the personal information at issue, designed to protect your personal information from loss, theft, misuse and unauthorized access, disclosure, alteration, and destruction.

Despite these measures, the Internet is not a fully secure environment and we cannot guarantee that your personal information won't be intercepted or improperly accessed.

## **CROSS BORDER DATA TRANSFERS**

To support our global operations, we share your information with members of our corporate group and other entities outside of your country of residence as described in the "How we share your information" section.

We transfer your personal information in accordance with law, and take steps to ensure that your information is appropriately protected.
